# WHAT WE'RE WORKING ON AT THE MOMENT

- Implementing the dataset changes so that there is a smooth integration of these changes into the clinical audit.
- Work has begun on the on the 2020/21 Annual Report. This will cover admissions and discharges between April 2020 and March 2021
- The data cleaning and analysis of the Post-Acute Organisational Audit dataset continues with the team looking to start report writing soon.
- Reviewing and updating the patients' area of our website. This will include updated consent forms, ward posters, and patient information leaflets.

### RESEARCH

It has been a busy time for SSNAP research.

The team have had two abstracts accepted to the European Stroke Conference:

"Are outcomes from thrombectomy clinical trials reproducible in real word practice? A comparison of the UK National Registry with the Hermes meta-analysis."

"Does direct admission to a thrombectomy preforming centre lead to better patient outcomes? Real World evidence using a nationwide dataset."

The team are also working on abstracts for the UKSF.

# **KEY APPROACHING DATES**

Data locking deadlines:

- Inpatient teams: 2<sup>nd</sup> August (April-June 2021 data).
- Non-inpatient teams: 2<sup>nd</sup> August (January-June 2021 data).
- Ambulance teams: 23<sup>rd</sup> August (April 2021 data).

# **REPORTING UPDATES**

From January-March 2021, SSNAP have begun reporting Index of Multiple Deprivation at national level for patients in England.

#### Resuming mandatory data collection

In order to support the National Clinical Audit and Patient Outcome Programme (NCAPOP), NHS England and Improvement have mandated a restart to data collection in England. Data collection in Wales has been ongoing and should continue. Click here for more information.

It is therefore anticipated that the January-March 2021 period will be the last where any adjustments will be made to case ascertainment are made and where scoring is not made publicly available. We are keen to work with any teams who need support returning to pre-COVID levels of participation, so please inform us if you anticipate any issues for April-June 2021 onwards.
