Overview of the national data opt-out

Who must comply?

All organisations providing or coordinating publicly funded health or social care in England

Is clinical audit exempt?

Clinical audit falls under the remit of "research and planning" and is not exempt at the moment

Allows a patient to choose if they want their confidential data info to be used for research and planning

When is the deadline?

What is the NDOO?

What does this mean for SSNAP?

Changes to data entry and flow

- Patients MUST be checked against the opt-out list before any data is entered by any provider along the stroke pathway
- SSNAP will not flow any data for patients who have opted out for linkage to ONS or HES



Updates to webtool and guidance

- Additional notifications on webtool when starting and locking a record
- Updated help notes and guidance
- Developing 'flag' to indicate when patient has provided informed consent

Consent and National Data Opt-Out



If a patient has agreed to a specific use of data, after being fully informed, then the national data opt-out does not apply. Even patients who have registered a national data opt-out can agree to take part in a specific research project or clinical trial, by giving their explicit consent.

What if....

My stroke unit has registered on SSNAP as two different units (HASU and SU) for the purposes of data entry, but we are one organization. Do we need to check the opt-out list when we transfer a SSNAP record from the HASU to SU?

Local practice is to enter all patients on SSNAP before checking against opt-out list. Before locking, we check against the list and then request to delete all of those who have opted out. Is this best practice? If my team screens a patient against the opt-out list, and they aren't 'opted-out', can we include them even if they have refused consent?

> We are a community rehab team and have just received a record from an acute team. When we checked against the NDOO list, this patient has optedout. Do we delete the record altogether?

- How will this affect expected cases (case ascertainment)?
- Will you be adjusting audit compliance scoring to account for the extra time that the NDOO process add to data entry?
- How does this affect non-admitting providers who don't start records?
- Are patients from Wales or NI subject to the NDOO?
